### Supreme Court Re-Constitutes Gender Sensitisation and Internal Complaints Committee with Justice Hima Kohli as its Chairperson

- The Supreme Court has reconstituted its Gender Sensitisation and Internal Complaints Committee. It will be a 12-member committee headed by top court judge Hima Kohli.
- This was done under the powers conferred by Clause 4(2) of the Gender Sensitisation and Sexual Harassment of Women at the Supreme Court of India (Prevention, Prohibition and Redressal) Regulations, 2013.

### Central government introduces separate mobile numbering series for service, transactional voice calls

 The Centre introduced a new numbering series, 160xxxxxxx, for making service or transactional calls.
 This will help citizens easily identify legitimate calls and curb unsolicited voice calls from telemarketers using 10-digit mobile numbers.

- Currently, 140xxxxxxx series has been allocated to telemarketers for making promotional/service/transactional voice calls. Since the 140xx series is being used extensively for promotional calls, consumers normally do not respond to such calls and many important service/transactional calls are missed.
- This resulted in the wide use of regular 10-digit numbers by genuine entities for making service/ transactional calls. This allowed fraudsters to deceive consumers by using 10-digit numbers.

#### Two bird sanctuaries of Bihar added to Ramsar list

- The Nagi and Nakti bird sanctuaries in Jamui district, Bihar are now recognised under the Ramsar Convention.
- These two new wetlands are man-made reservoirs in the Jhajha forest range of Jamui. Their catchments feature dry deciduous forests surrounded by hills.
- Both sites were declared Wetlands of International importance on World Environment Day on June 5.
- A Ramsar site is a wetland site designated to be of international importance under the Ramsar Convention. This convention is also known as The Convention on Wetlands and is an international environmental treaty signed on February 2, 1971, in Ramsar, Iran, under the auspices of UNESCO.

#### NOTA creates a record in Indore

- BJP's sitting MP from Indore Shankar Lalwani won by a record margin of 11,75,092 votes in a contest where NOTA created a record with 2.18 lakh voters opting for the 'None Of The Above' option in the Lok Sabha elections.
- He defeated his Congress rival Pankaj Ahirwar by 4,03,312 votes.
- NOTA stands for None of the above and was introduced by the Election Commission of India in 2013.

### Kozhikode becomes India's first UNESCO 'City of Literature'

- Kozhikode in North Kerala, known for its rich cultural heritage, was officially declared as India's first UNESCO 'City of Literature'.
- In October 2023, Kozhikode earned a place in the 'Literature' category of the UNESCO Creative Cities Network (UCCN).

### Srinagar was named the 'World Craft City'

- Srinagar has become the fourth Indian city to be recognised as a 'World Craft City' by the World Craft Council (WCC), three years after it was designated as part of the UNESCO Creative City Network (UCCN) for crafts and folk arts.
- Jaipur, Malappuram and Mysore are the other Indian cities that were previously recognised as World Craft Cities.

### Govt employees to get six-month maternity, child care leave for surrogacy

- The Central Civil Services (Leave) Rules, 1972, have been updated to allow 'commissioning mothers' who opt for surrogacy 180 days of maternity leave.
- Under this, childcare leave will be provided to commissioning mothers with less than two surviving children. Additionally, 'commissioning fathers' are eligible for a 15-day paternity leave under the amended rules.
- Additionally, the Central Civil Services (Leave) (Amendment) Rules, 2024, state that commissioning mothers with fewer than two surviving children may avail of the child care leave.
- The rules also define the 'surrogate mother' as the woman who bears the child on behalf of the commissioning mother, while the 'commissioning father' refers to the intended father of the child born through surrogacy.
- Recently, the Centre revised the Surrogacy (Regulation)
  Rules of 2022, permitting married couples to use donor
  eggs or sperm when one partner faces a medical
  condition.
- According to the amended Surrogacy (Regulation)
   Rules of 2022, it is mandated that the District Medical

Board must confirm the presence of a medical condition in either the husband or wife, which requires the use of a donor gamete.

#### Central government forms a committee to review NTA

- The central government constituted a seven-member high-level committee to review the National Testing Agency (NTA) and its operations to ensure fair conduct of exams.
- The committee is led by former ISRO chairman Dr. K Radhakrishnan and includes former AIIMS Director Randeep Guleria, among others.

#### PM Modi launches 'Ek Ped Maa ke Naam' campaign

- Prime Minister Narendra Modi launched the 'Ek Ped Maa Ke Naam' campaign to commemorate World Environment Day on June 5. He planted a Peepal tree sapling at Buddha Jayanti Park in Delhi.
- He urged people in India and around the world to plant a tree in the coming days as a tribute to their mother.

### NHRC takes a serious view of 'Nata Pratha', issues notice to four states

- The National Human Rights Commission (NHRC) has issued a notice to four states—Uttar Pradesh, Madhya Pradesh, Rajasthan and Gujarat over the social practice of Nata Pratha, where girls are sold by their family members under the guise of marriage.
- The commission has requested the Union Ministry of Women and Child Development and the concerned states to present an action taken report within eight weeks.
- This notice follows a 2020 case in which a father sold his daughter for 2.5 lakhs and later filed a complaint with the commission upon discovering her dead body.

### Rajaji Raghati Biosphere (RRB), India's first private biosphere

- India's first biosphere, the Rajaji Raghati Biosphere (RRB) was created in a tiger reserve within Rajaji National Park, Uttarakhand.
- Rajaji National Park is named after the freedom fighter
   C. Rajgopalachari, also known as 'Rajaji'.

- Under the provisions of the Wild Life Protection Act 1972, it was declared as Rajaji Tiger Reserve.
- It was created by two environmentalists- Jai Dhar Gupta and Vijay Dhasmana.
- Vijay Dhasmana is known for restoring Aravali landscapes. The duo is also developing a second biosphere above the Koyna River in the buffer zone of the Sahyadri Tiger Reserve near Pune, Maharashtra, along the Western Ghats.

### Indian universities to offer admissions twice a year on lines of foreign varsities: University Grants Commission (UGC)

- Indian universities and higher education institutions will now be allowed to offer admissions twice a year on lines of foreign universities.
- The two admission cycles will be July-August and January-February from the 2024-25 academic session.
- Biannual university admissions will help students maintain motivation since they do not have to wait one full year to be admitted if they miss admission in the current cycle. With biannual admissions in place, industries can also do their campus recruitment twice a year, improving employment opportunities for graduates.

- The Sthal houses the statues of India's eminent leaders and freedom fighters that were previously dispersed across different places in the Parliament House complex.
- The initiative aims to enhance the visitor experience by making it easier to access and using modern technology, such as QR codes, to narrate the life stories of these inspiring figures of Indian history.

### PM Narendra Modi inaugurates the newly built campus of Nalanda University, Rajgir, Bihar

 Prime Minister Narendra Modi inaugurated the newly built campus of Nalanda University in Rajgir,

- Bihar. Nalanda University was a great example of our identity and traditions to the world.
- In the ancient times, the Nalanda University was identified as the centre of education.
- The ruins of ancient Nalanda comprise the archaeological remains of a monastic and scholastic institution. It includes stupas, shrines, viharas (residential and educational buildings) and important artworks in stucco, stone and metal.

### India Contributes USD 1.169 Mn to continue the promotion of Hindi at the United Nations

- The Government of India has contributed USD 1,169,746 for the 'Hindi @ UN' project to expand the use of Hindi in the United Nations.
- India has been partnering with the UN Department of Global Communications (DGC) since 2018 by providing an extra-budgetary contribution to mainstream and consolidate news and multimedia content of DGC in the Hindi language.

## The National Institute of Indian Medical Heritage (NIIMH) in Hyderabad designated a WHO Collaborating Centre (CC) for traditional medicine research

- The World Health Organisation (WHO) has designated the National Institute of Indian Medical Heritage (NIIMH) in Hyderabad, under the Ministry of Ayush, as a WHO Collaborating Centre (CC) for traditional medicine research.
- This recognition has been granted for four years.
- This will make NIIMH the third Indian institute to receive such an honour. The other Indian institutes are- the Institute for Teaching & Research in Ayurveda, Jamnagar and the Morarji Desai National Institute of Yoga (MDNIY), New Delhi.
- NIMH was established in 1956 and has been a pioneer in various digital initiatives of Ayush such as AMAR Portal, Showcase of Ayurvedic Historical Imprints (SAHI) Portal and the NAMASTE Portal.

### UP govt to set up bioplastic park in Lakhimpur Kheri at ₹ 2,000 crore

- The Uttar Pradesh government will set up a bioplastic park in Gola Gokarannath of Lakhimpur Kheri district at an investment of ₹ 2,000 crore.
- The park will be developed by the Balrampur Sugar Mills Firm over 1,000 hectares in Kumbhi village of the district on Public Private Partnership (PPP) mode.
- The Uttar Pradesh Expressways Industrial Development Authority (UPEIDA) will serve as the nodal agency for the park's development.

### World's First Asian King Vulture Conservation Centre launched in Uttar Pradesh

- Uttar Pradesh has established the world's first conservation and breeding centre named Jatayu Conservation and Breeding Centre, for Asian king vultures in Maharajganj district.
- It aims to improve the population of Asian king vultures, which was listed as critically endangered by the International Union for Conservation of Nature's Red List in 2007.

### Meta AI launched in India on WhatsApp, Facebook, Instagram

- Facebook parent Meta made its artificial intelligence chatbot Meta AI available to use in India months after the tech giant tested the AI chatbot with a section of users in India.
- It will be available in English across the company's apps-WhatsApp, Facebook, Instagram and Messenger.

June 2024

 The chatbot has been rolled out in more than 12 countries including the United States, Australia, Canada, New Zealand, Singapore, South Africa, Uganda and Zimbabwe.

### India's largest leopard safari opens at Bannerghatta, Bengaluru

• South India's first and the country's largest leopard safari was inaugurated at the Bannerghatta Biological

Park (BBP), Bengaluru. The safari is set up in a 20-hectare area that meets the strict rules of the Central Zoo Authority for safety and ecosystem mimicry.

 It includes several protective measures, such as a railway barricade, a 4.5-meter-high chain-link fence, and 1.5-meter metal sheets installed at a 30-degree angle.

### Railway Protection Force (RPF) launches Sangyaan App

- The Director General of the Railway Protection Force (RPF) Shri Manoj Yadava launched the mobile application- Sangyaan App.
- It was designed and developed by the Tech Team of RPF to provide in-depth information on three new Criminal Acts: the Bharatiya Nyaya Sanhita (BNS) 2023, the Bharatiya Nagarik Suraksha Sanhita (BNSS) 2023, and the Bharatiya Sakshya Adhiniyam (BSA) 2023.
- The Sangyaan App aims to educate and empower RPF Personnel by providing comprehensive information to understand the provisions of both new and old criminal laws while highlighting the relevance of these new acts in the context of RPF operations.

### Central zone of Indian Railways installs first-ever floating solar plant of Indian Railways

- The Central Railway has installed a floating solar plant of 10 MWp capacity in the Igatpuri lake located in the Western Ghats.
- The plant is committed to leveraging renewable energy sources, utilising solar power, installing wind-energy resources, providing adequate passenger amenities and contributing significantly towards the railways' goal of a green Earth'.

### Cabinet approves assistance for 3 crore more houses under PM AWAS Yojana

 The Union Cabinet approved the assistance to 3 crore additional rural and urban households for the construction of houses, to meet the requirements arising out of the increase in the number of eligible families.

- PMAY or Pradhan Mantri Awas Yojana was launched in 2015-16. Under this, assistance is provided to eligible rural and urban households for the construction of houses with basic amenities.
- The houses constructed under PMAY come with amenities such as toilets, LPG connection, electricity and functional taps through convergence with other schemes of central and state governments.

### Cabinet approves Central Sector Scheme 'National Forensic Infrastructure Enhancement Scheme' (N.F.I.E.S.)

- The Union Cabinet approved the proposal of the Ministry of Home Affairs for the Central Sector Scheme
   National Forensic Infrastructure Enhancement Scheme (NFIES).
- Under the scheme, off-campus labs of the National Forensic Sciences University will be set up across 28 states and UTs and the existing structure will be enhanced.
- Additionally, Central Forensic Science laboratories will also be established along with the enhancement of the existing infrastructure of the National Forensic Sciences University (NFSU), Delhi.
- With the enactment of new criminal laws that mandate forensic investigation for offences involving punishment of seven years or more, a significant increase in the workload of forensic science laboratories is expected.
- The establishment of additional campuses of the NFSU and new Central Forensic Science Laboratories would address the shortage of trained forensic manpower, alleviate the caseload/pendency of forensic laboratories, and align with the government's goal of securing a high conviction rate of more than 90%.

### National Crime Records Bureau (NCRB) launches 'NCRB SANKALAN of CRIMINAL LAWS' App

 NCRB has unveiled a mobile application- NCRB Sankalan of Criminal Laws. It will be a comprehensive

- guide consolidating essential information about the upcoming legal reforms in one accessible platform.
- The mobile application is designed for a wide audience ranging from the general public to legal professionals.
- The app includes detailed compilations of three major legislations-Bharatiya Nayaya Sanhita (Indian Penal Code), Bharatiya Nagrik Suraksha Sanhita (Code of Criminal Procedure), and Bharatiya Sakshya Adhiniyam (Indian Evidence Act).
- It provides users with an indexed structure linking all chapters and sections of these new laws, facilitating ease of navigation and reference.

### NHAI to enhance green cover along the National Highways

- NHAI will undertake a unique initiative to plant Miyawaki plantations on land parcels adjacent to National Highways at various locations.
- A total land area of over 53 acres has been identified at different places in and around Delhi-NCR to establish the Miyawaki plantations.
- Miyawaki plantations, also known as Miyawaki method, is a Japanese approach to ecological restoration and afforestation development. It will create dense, native, and biodiverse forests in a short time. These forests retain groundwater and help to recharge the groundwater table.
- This will help in the improvement of air and soil quality.
   It will also help in biodiversity conservation, rapid growth of green cover, efficient carbon absorption, soil restoration and habitat creation for local flora and fauna.

#### Cabinet okays ₹76,200-cr port at Vadhavan in Maharashtra

- The Union cabinet approved a major port at Vadhavan near Dahanu in, Palghar, Maharashtra at a cost of ₹ 76,200 crore.
- It will be an all-weather greenfield deep draft port set up by Vadhavan Port Project Limited (VPPL).
- VVPL is a Special-Purpose Vehicle (SPV) formed by Jawaharlal Nehru Port Authority (JNPA) and Maharashtra

Maritime Board (MMB) with a shareholding of 74% and 26%, respectively.

### NHAI signs MoU with IIIT-Delhi to enhance road safety through Artificial Intelligence (AI)

- National Highways Authority of India (NHAI) and Indraprastha Institute of Information Technology (IIIT), Delhi signed an agreement to leverage Artificial Intelligence (AI) based solutions for improvement in the availability of road signs on National Highways.
- As a part of the agreement, IIIT Delhi will conduct surveys to collect imagery and other related data related to the availability and condition of road signs on selected National Highway stretches.
- Around 25,000 km of tentative length of Highways stretches will be covered under this project.
- The data collected through surveys will be processed by IIIT Delhi through the deployment of Artificial Intelligence for accurate identification and classification of road signs.

### Centre notifies anti-paper leak law-Public Examinations (Prevention of Unfair Means) Act, 2024

- The central government has notified a law, the Public Examinations (Prevention of Unfair Means) Act, 2024 against cheating, paper leaks, and irregularities in competitive examinations.
- It came into effect on June 21, 2024, and under this, the offenders will be subjected to a jail term of up to 10 years and a fine of up to ₹ 1 crore. The act provides punishments for "leakage of question paper or answer key", "directly or indirectly assisting the candidate in any manner unauthorisedly in the public examination" and "tampering with the computer network or a computer resource or a computer system".
- Both individuals and institutions are also liable to punishments.
- The Act aims to prevent malpractice in the public examinations held by the Union Public Service Commission, the Staff Selection Commission, the railways, banking recruitment examinations and other examinations held by the National Testing Agency.

### The Bureau of Indian Standards (BIS) introduces two new standards to enhance the Safety and Quality of Electric Vehicles in India

 BIS has introduced two new standards- IS 18590: 2024 and IS 18606: 2024, aimed at enhancing the safety of electric vehicles in the L, M, and N categories.

- L refers to two-wheelers, while the M and N categories correspond to four-wheelers and good trucks, respectively.
- These focus on the main parts of electric cars, buses and trucks, especially the powertrain (which includes parts like motor and transmission.
- These standards are crucial in driving the transition to a more sustainable, environmentally friendly and efficient transportation system in the country.

- Paraguay has become the 100<sup>th</sup> country to join the International Solar Alliance (ISA) as a full member.
- The ISA, co-founded by India and France during the 2015 United Nations Climate Change Conference (COP21) in Paris, aims to promote solar energy deployment worldwide.
- It is a collaborative platform for member countries to increase energy access, ensure energy security and drive the transition towards sustainable energy sources.

- Oleg Kononenko, a 59-year-old Russian cosmonaut has become the first person to spend 1,000 days in space.
- He has made five journeys to the International Space Station (ISS) since 2008.
- His current trip to the ISS began Sept. 15, 2023, when he launched alongside NASA astronaut Loral O'Hara and compatriot Nikolai Chub.
- Kononenko first took the cumulative space-time record in February 2024, when he surpassed the total of 878 days, 11 hours, 29 minutes and 48 seconds set by fellow Russian Gennady Padalka in 2015.

- Brand new banknotes featuring the portrait of the new monarch, King Charles III, have been introduced in the market.
- The Bank of England has asked people to return old banknotes featuring the portrait of Queen Elizabeth. The old banknotes featuring Queen Elizabeth II will continue to remain valid and will remain in circulation along with new ones to ease the transition.

### Denmark becomes the first country to impose a tax on livestock carbon emissions

- Denmark will introduce a tax on livestock carbon dioxide emissions from 2030, making it the first country to do so.
- Agriculture is Denmark's biggest source of pollution, even though the country exports a lot of dairy and pork goods. Each cow will be taxed at 672 krone (\$96) a year starting in 2030.
- The tax will begin at 300 krone (\$43) per tonne of CO2equivalent emissions from animals in 2030 and rise to 750 krone (\$107) by 2035.

### Sino-French satellite launched to detect the most powerful explosions in the universe

- Space Variable Objects Monitor (SVOM), the satellite jointly developed by China and France was launched into orbit from the Xichang Satellite Launch Center in Sichuan province.
- It is the most powerful satellite yet for studying Gamma-Ray Bursts (GRBs), which result from some of

- the universe's most explosive events such as the birth of black holes and neutron star collisions.
- It is the first astronomy satellite jointly developed by China and France.

### Pakistan launches 'Operation Azm-i-Istehkam' or 'Resolve for Stability'

- Pakistan has launched Operation Azm-i-Istehkam to oppose and dismantle terrorist networks from its territory. The operation will not only include military action, but socio-economic uplift to deter extremism.
- This initiative follows Prime Minister Shehbaz Sharif's review of the country's counterterrorism operations, focusing on the National Action Plan adopted after the December 2014 Peshawar Army Public School attack, which resulted in over 140 deaths, mostly students.

### European Space Agency (ESA) develops Zero Debris Satellite

• European space industry giants Airbus, OHB, and Thales Alenia Space have signed contracts with ESA to develop large low Earth orbit (LEO) satellite platforms adhering to Zero Debris standards.

 This initiative aims to pave the way for zero-debris production lines, a crucial move to preserve lower Earth orbits for future use.

### REPORTS, RANKINGS AND INDEX

### Mumbai retains top spot as India's most expensive city for expats: Mercer report

- According to Mercer's 2024 Cost of Living Survey, Mumbai remains the most expensive Indian city for expatriates. Hong Kong tops the global ranks yet again with Singapore at the second rank followed by Zurich.
- Globally, Mumbai is ranked at 136th position and New Delhi at 164th position. Chennai is ranked at 189th position and Bengaluru at 195th position.
- The report ranked 226 cities based on the cost of more than 200 items, including transportation, food, clothing, and entertainment.

### India becomes the world's third-largest domestic aviation market

- According to data compiled by aviation analytics firm Official Airline Guide (OAG), India is now third in the aviation market after airlines such as IndiGo and Air India have expanded their fleet size to cater to the surge in air passengers.
- The data show India's domestic airline capacity doubled in the last 10 years from 7.9 million seats in April 2014 to 15.5 million in April 2024.
- The world's largest domestic aviation market is the U.S. followed by China.

#### Uttar Pradesh leads India in compressed biogas production

- According to a report by the Center for Science and Environment (CSE), Uttar Pradesh could create 24% of India's CBG (Compressed BioGas).
- Towns like Muzaffarnagar, Meerut, and Saharanpur are key areas for making CBG because it has a lot of feedstock.

#### Environment Performance Index (EPI) 2024

• According to the Environment Performance Index (EPI) 2024, India ranked 176th among 180 countries.

- This is a mild improvement from the last EPI, in which India came at the bottom.
- This index is released by the Yale Center for Environmental Law and Policy and the Columbia Center for International Earth Science Information Network.
- The 2024 EPI has 58 indicators, including biodiversity, air pollution, air and water quality, waste management, emission growth rates, projected emissions, etc., under the three main heads of ecosystem vitality, environmental health and climate change.

### Virat Kohli tops celebrity rankings with a brand value of \$227.9 million

- According to Kroll's 'Celebrity Brand Valuation Report 2023: Brands, Business, Bollywood'- Cricketer Virat Kohli has reclaimed the top position in brand value, now reaching \$227.9 million, surpassing Bollywood star Ranveer Singh, who holds the second spot with \$203.1 million.
- Bollywood actor Shah Rukh Khan has claimed the third position with a brand value of \$120.7 million due to the success of three blockbuster hits in 2023, marking his comeback among India's top five celebrity endorsers since 2020.
- The report ranks India's most influential celebrity brands by assessing their brand values derived from endorsements and social media presence.
- The combined brand value of the top 25 Indian celebrities reached \$1.9 billion in 2023, marking an 18% increase from the previous year.

### India is the world's second-largest emitter of nitrous oxide

 According to 'Earth System Science Data', India is the world's second-largest emitter of nitrous oxide after China. Nitrous oxide emissions largely come from nitrogen fertilizer usage and animal manure. • In 2020, India accounted for nearly 11% of global manmade N2O emissions, second only to China, which contributed 16%.

#### Global Peace Index

- According to the Global Peace Index, Iceland is the most peaceful country, followed by Ireland, Austria, New Zealand and Singapore. Iceland has topped the list since 2008.
- India was ranked 126 out of 163 countries, with an overall score of 2.31. In previous rankings, it stood at 139 in GPI 2020 and 141 in GPI 2019.
- Yemen is now the least peaceful country, followed by Sudan, South Sudan, Afghanistan and Ukraine.
- The index is published by the Institute for Economics and Peace (IEP).
- GPI provides a comprehensive measure of global peacefulness, evaluating 163 independent states and territories. This report highlights the trends, results and economic impacts of violence across the world, offering valuable insights into the current state of peace and the factors influencing it.

### Infosys ranks among the top 100 most valuable brands in the world

- According to Kantar's annual 'BrandZ Most Valuable Global Brands report,' Infosys was ranked the 74<sup>th</sup> most valuable brand in the world and the 20<sup>th</sup> most valuable global B2B technology brand.
- It has been named in the '100 most valuable brands' of the world for the third consecutive year.

### Gautam Adani reclaims the title of Asia's richest man with a net worth of \$111 bn

- According to the Bloomberg Billionaires Index, Gautam Adani, chairman of multinational conglomerate the Adani Group, has reclaimed the title of the richest person in Asia with a net worth of \$111 billion.
- Ambani stands at 12th rank with a net worth of \$109 billion.
- According to the Bloomberg Billionaires Index, Bernard Arnault is currently the richest person in the world with a net worth of \$207 billion. He is followed by Elon Musk and Jeff Bezos with a total wealth of \$203 billion and \$199 billion respectively.

### Artificial Intelligence Preparedness Index (AIPI)

- The International Monetary Fund (IMF) released an Artificial Intelligence Preparedness Index (AIPI) dashboard that tracks 174 economies globally for AI readiness.
- India ranks at the 72nd position, with Bangladesh (0.38) at 113, Sri Lanka (0.43) at 92 and China (0.63) at 31.
- Denmark (0.78), and the United States (0.77) are among the highest-rated AEs, with India categorised as an EM with a 0.49 rating.
- Each country's rating is analysed based on its digital infrastructure, human capital, labour policies, innovation, integration and regulation.
- The Index has categorised each country into Advanced Economy (AE), Emerging Market Economy (EM) and Low-Income Country (LIC).

#### QS World University Ranking 2025

- In the latest edition of the QS World University Ranking, 61% of Indian universities' ranking has improved, with IIT Bombay gaining the top spot in India. It has climbed from 149 rank to 118 in the 2025 rankings.
- IIT Bombay is followed by IIT Delhi and the Indian Institute of Science (IISc), Bengaluru with the two institutes ranked second and third in India, respectively.
- Globally, the Massachusetts Institute of Technology (MIT) retained the 'best institute in the world' position for the 13<sup>th</sup> time this year.

### World Investment Ranking

- According to a report released by the United Nations Conference of Trade and Development (UNCTAD), India slipped seven ranks to fifteen in the World Investment Ranking in 2023 as foreign direct investment inflows fell 43% to \$28 billion.
- However, despite the fall in global rankings according to value, India remained one of the top destinations in terms of greenfield project announcements and international project deals.
- The US attracts the highest FDI at \$311 billion, followed by China, Singapore and Hong Kong.

- The theme was 'Farmer Centric Innovations in Dairying.'
- It featured deliberations bringing together leaders and experts from the global dairy sector.

#### 50th G-7 Summit 2024

• The 50<sup>th</sup> G-7 summit was held from June 13-15, 2024

- at Borgo Egnazia in the city of Fasano in Apulia, Italy. This summit marked the 50<sup>th</sup> anniversary of the group.
- The leaders decided to promote concrete G-7 PGII (Partnership for Global Infrastructure and Investment) initiatives.
- G-7 nations committed to promoting the IMEC (India-Middle East-Europe Economic Corridor), which aims to create a comprehensive transportation network, comprising rail, road, and sea routes, connecting India, the Middle East, and Europe.
- G-7 is a group of the most developed and advanced economies in the world. The member countries are-France, Germany, Italy, the United Kingdom, Japan, the United States and Canada.

 He became the only Indian filmmaker to receive the 'Liv Ullmann Peace Prize', in Chicago, for his Gujarati film, 'Harun-Arun'.

### Sahitya Akademi announces Yuva Puraskar winners for 2024

- The Sahitya Akademi Yuva Puraskar, commonly referred to as the Yuva Puraskar, is a prestigious literary honour bestowed by the Sahitya Akademi, India's National Academy of Letters.
- The Yuva Puraskar aims to recognise young writers under 35 for their exceptional literary works in one of the 24 major Indian languages.
- This year's Yuva Puraskar for English was awarded to K Vaishali for her memoir Homeless: Growing Up Lesbian and Dyslexic in India (Yoda Press), and the Bal Sahitya Puraskar for English, to Nandini Sengupta for her book The Blue Horse and Other Amazing Animals from Indian History (Hachette India).
- The Bal Sahitya Puraskar has been awarded for seven novels, six books of poetry, four stories, five short stories, one play, and one historical fiction.

- Afghanistan's Rahmanullah Gurbaz finished the tournament with the most runs – 281 and Afghanistan's Fazalhaq Farooqi was the joint-highest wicket-taker along with India's Arshdeep Singh – 17 wickets.

#### Rohit Sharma becomes first batter to hit 200 sixes in T20Is

- Rohit Sharma becomes the first player to hit 200 sixes in T20Is during the T20 World Cup 2024.
- New Zealand's Martin Guptill is closest to his record with 173 sixes.

### Rohit Sharma becomes the first cricketer to hit 600 sixes in international cricket.

- Rohit Sharma, known as the 'Hitman,' made history by becoming the first cricketer to hit 600 sixes in international cricket.
- He is the first Indian and the second player globally, after Chris Gayle, to hit 100 sixes in ICC white-ball tournaments (T20 and ODI).
- This record was made in India and Ireland match that was played at the Nassau County International Cricket Stadium in New York, USA.

#### U-17 Asian Wrestling Championship 2024

 Indian wrestlers won 11 medals, including four gold, two silver, and five bronze in the Under-17 Asian Wrestling Championship 2024.

- All four gold medals were won by the Indian women's team- Dipanshi – Gold in 46kg, Muskan – Gold in 53kg, Rajnita – Gold in 61kg, and Mansi Lather – Gold in 69kg.
- The championship was held in Amman, Jordan.

#### India Joins World Boxing (WB)

- The Boxing Federation of India (BFI) joined World Boxing (WB), a newly formed body after the International Olympic Committee (IOC) refused to recognise the International Boxing Association (IBA).
- The IOC had previously warned that any boxer whose National Federation adheres to the IBA would be excluded from the Olympic Games in Los Angeles 2028. The IOC's stance was further reinforced after the IBA announced prize money for Olympic medalists at the Paris Games.
